AFFIDAVIT CORRECTING CHAIN OF TITLE
FOR REGISTRATION NO. 3,339,402 (CMAX)

1. I, Renee P. Simonton, am of legal age, am a citizen of the United States and reside in Delaware.
2. I am a Vice President of Accuity Inc., a corporation organized under the laws of Delaware.
3. I have personal knowledge of the Accuity Inc. trademark portfolio and of the ownership by Accuity Inc. of the mark CMAX and Registration No. 3,339,402, and the documents that transferred ownership of this mark and registration to Accuity Inc.
4. Effective December 30, 2010, as reflected in the Trademark Nunc Pro Tunc Assignment executed on June 30, 2014, and recorded on July 22, 2014 at Reel 5327, Frame 0204 of the Assignment Branch records of the United States Patent and Trademark Office ("USPTO"), Registration No. 3,339,402 for the mark CMAX and all common law rights and good will associated with this mark were assigned by Source Media Inc. to Accuity Inc. See Exhibit A to this Affidavit.
5. Source Media Inc. was "converted" from a Delaware corporation to a Delaware limited liability company, Source Media LLC, on or about December 30, 2011. The formation document for Source Media LLC was recorded on May 19, 2014, at Reel 5820, Frames 137 – 139. See Exhibit B to this Affidavit.
6. As reflected by the Trademark Nunc Pro Tunc Assignment, Exhibit A, the mark CMAX and Registration No. 3,339,402 were assigned to Accuity Inc. almost a year prior to the conversion of Source Media Inc. to Source Media LLC (per Exhibit B).
7. Consequently, Source Media Inc. did not own the mark CMAX or Registration No. 3,339,402 at the time Source Media Inc. was converted to Source Media LLC.
8. On May 19, 2014, counsel for Source Media LLC recorded the documentation of December 30, 2011 designated as a "conversion", apparently without knowledge of the prior transfer of the

CMAX mark and Registrations No. 3,339,402 by Source Media Inc. on December 31, 2010 and inadvertently included on the assignment recordation Cover Sheet a reference to Registration No. 3,339,402. See Exhibit C to this Affidavit.

9. As a result, the "conversion" document, Exhibit B, recorded May 19, 2014, has incorrectly been included in the chain of title for Registration No. 3,339,402 in the records of the Assignment Branch of the USPTO.

10. I hereby swear that the statements made in this Affidavit are from my personal knowledge and my knowledge of the documents referenced in this Affidavit, and are true or are believed to be true.
