CORRECTIVE ASSIGNMENT**DECLARATION OF KYRAN CASSIDY**

The undersigned, Kyran Cassidy, states:

1. I am Secretary of HarperCollins Christian Publishing, Inc. and I am authorized to execute this declaration on the company's behalf.
2. HarperCollins Christian Publishing, Inc. ("HCCP") is a corporation organized and existing under the laws of the state of Tennessee. Prior to May 31, 2013, HCCP was known as "Thomas Nelson, Inc."
3. On October 29, 2012, Thomas Nelson, Inc. assigned Registration No. 2,109,470 to LifeWay Christian Resources of the Southern Baptist Convention ("Lifeway").
4. On November 2, 2012 the Assignment from Thomas Nelson, Inc. to LifeWay was recorded with the Assignment Division of the United States Patent and Trademark Office on Reel 004905/Frame 0442.
5. On May 31, 2013 Thomas Nelson, Inc. changed its name to HarperCollins Christian Publishing, Inc.
6. On June 25, 2013 HCCP recorded its Change of Name with the Assignment Division of the United States Patent and Trademark Office on Reel 005055/Frame 0733 in connection with several trademark registrations, including Registration No. 2,109,470.
7. Although HCCP had initially been advised that this mark was in the name of Thomas Nelson, it had, in fact, been assigned to Lifeway as mentioned above. As such, the recordal of the Name Change in connection with Registration No. 2,109,470 was done in good faith, but in error, and HCCP wishes to restore the record of ownership of Registration No. 2,109,470 to LifeWay.
8. HCCP hereby respectfully requests that the Assignment Division remove Reel 005055/Frame 0733.
9. I am hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001 and that such willful false statements may jeopardize the validity of the application or any resulting registration.
10. I declare that the facts set forth in this declaration are true and that all statements made of my own knowledge are true and that all statements made on information and belief are believed to be true.
