TRADEMARK ASSIGNMENT

WHEREAS, Aviation Capital Partners Group, LLC, a Delaware limited liability company, having a registered office address of 1221 Brickell Avenue, Suite 2660, Miami, Florida 33131 ("ACPG") was the owner of all right, title and interest in and to certain trademarks, service marks and/or trade names, as identified in Schedule A, attached hereto and incorporated herein by reference (collectively, the "Assigned Marks"), and the goodwill associated therewith; and

WHEREAS, Eastern Air Lines Group, Inc., a Delaware corporation, having a registered address of Building 5A, Miami International Airport, Miami, Florida 33142 ("Eastern"), has acquired from ACPG all right, title and interest in and to the Assigned Marks, and the goodwill associated therewith; and

WHEREAS, ACPG and Eastern have executed a certain Restricted Common Stock Purchase Agreement, with an effective date of October 19, 2013 ("CSPA"), which provides for this Assignment of the Assigned Marks; and

WHEREAS, it is desired that the assignment of the Assigned Marks, and registrations thereof and applications therefore, be made of record in the United States Patent and Trademark Office, and any other appropriate Patent and Trademark Office;

NOW, THEREFORE, pursuant to said CSPA, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ACPG makes the following assignment and agrees as follows:

1. Assignment. ACPG hereby sells, assigns, transfers and sets over to Eastern the entire right, title and interest in and to the Assigned Marks, together with the goodwill of the business associated therewith, and the registrations thereof and applications therefore, along with that portion of the business to which the Assigned Marks pertain, and all rights to any damages and profits, due or accrued, arising out of past infringements of the Assigned Marks, and the right to sue for and recover such past infringements or any other violations of the Assigned Marks.

2. Terms. The terms and covenants of this Assignment shall inure to the benefit of Eastern, its successors, assigns and other legal representatives, and shall be binding on ACPG and its successors, assigns and other legal representatives.

3. Cooperation. ACPG agrees to execute any and all documents and to do all other lawful acts as may be required by Eastern to establish and protect the rights assigned herein.

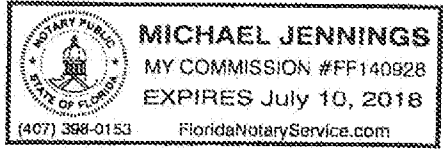
