NOW THEREFORE in consideration of the payment to the Assignor by the Assignee of the sum of ONE DOLLAR (\$1.00) in the lawful money of the United States of America and other good and valuable consideration, the receipt of which is hereby acknowledged by the Assignor, the Assignor does hereby sell, assign, transfer and convey unto the Assignee, its successors and assigns, all of the right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by and associated with the Trademarks, including all common law rights and trademark registrations for the Trademarks, and any application for Trademarks in any country to be filed, the same to be held and enjoyed by the Assignee as it would have been held and enjoyed by the Assignor had the sale, assignment, transfer and conveyance not been made; together with all rights to past, present and future income, royalties, and license fees deriving from the Trademarks, all claims for damages by reason of past, present and future infringements of the Trademarks and the right to sue for and collect such damages, as permitted under the applicable laws for any jurisdiction or country in which such claims may be asserted for the use and benefit of Assignee and its successors, assigns and other legal representatives.

THE Assignor hereby further agrees, undertakes and covenants that it will, without charge to Assignee, sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by the Assignee or its legal representatives, for the purpose of obtaining or registering any Trademarks therein, and perform any other act deemed necessary or desirable by Assignee in order that all of their right, title and interest in the Trademarks may be vested in the Assignee, its successors and assigns. Such acts may include assistance and cooperation in the registration and enforcement of applicable intellectual property rights or other legal proceedings, including providing documents and materials in the possession or control of Assignor, testifying in any legal proceedings, signing lawful papers and making all lawful oaths at Assignee's expense, and generally doing everything that is reasonable to aid Assignee in obtaining and enforcing proper protection for applicable intellectual property rights. If Assignee or its successor or assignee is unable, for any reason, to obtain a signature of an Assignor on a document necessary to perfect the transfer or assignment of the Trademarks, such Assignor hereby irrevocably appoints Assignee as its agent and attorney-in-fact, which appointment is coupled with an interest, to act for and on behalf of such Assignor to execute, verify, and file any documents with the same legal force and effect as if executed by such Assignor.

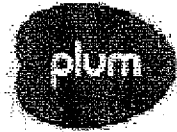
