TRADEMARK RELEASE OF SECURITY INTEREST

This TRADEMARK RELEASE OF SECURITY INTEREST (this “Release”) is made as of September 12, 2014, by PNC BANK, NATIONAL ASSOCIATION, as successor to RBC BANK (USA) (“Secured Party”).

WITNESSETH:

WHEREAS, Secured Party and PRECISION DOORS & HARDWARE, LLC, a Delaware limited liability company (“Grantor”), were parties to that certain Trademark Security Agreement, dated as of April 30, 2010 (the “Security Agreement”; capitalized terms used but not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement), pursuant to which Grantor granted a security interest to Secured Party in, among other things, all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Exhibit A hereto, and which Security Agreement was recorded with the U.S. Patent and Trademark Office at Reel: 004206/Frame: 0215; and

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks set forth on Exhibit A (the “Specified Trademark Collateral”) and reassign the same to Grantor;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor’s right, title and interest in, to and under Specified Trademark Collateral.
2. To the extent, if any, that following the release as set forth in Section 1 above, Secured Party retains or would retain any right, title or interest in or to the Specified Trademark Collateral or any goodwill of any business conducted in connection therewith, Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Secured Party, all of Secured Party’s right, title and interest in, to and under the Specified Trademark Collateral, and the goodwill of Grantor’s business connected with the use of and symbolized by the Specified Trademark Collateral.


