TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 16, 2014, by **MADISON CAPITAL FUNDING LLC**, in its capacity as Agent for the Lenders (in such capacity, "**Grantee**"). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Assignment described below.

WITNESSETH:

WHEREAS, Grantee and SAV-A-LIFE, LLC, an Illinois limited liability company ("**Grantor**"), were parties to that certain Trademark Security Agreement dated as of January 31, 2013 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral as security for certain obligations owing by Grantor to Agent, including, without limitation, the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the United States Patent and Trademark Office on February 5, 2013, at Reel 4956 Frame 0092; and

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases and discharges fully its security interest in and lien on all of Grantor's right, title and interest in and to the Trademark Collateral.
2. Grantee hereby releases its security interest in and lien on the Trademark Collateral.
3. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.
