Assignor further agrees that, upon request by Assignee, Assignor shall execute and deliver such documents and instruments and perform such other acts as may be reasonably required in order to vest all of Assignor’s right, title and interest in and to the Mark in Assignee, including the delivery to Assignee of any relevant evidence in Assignor’s possession or control that may be reasonably required to support the foregoing.
