RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST is dated as of 8/29/14. Reference is made to the Security Interest dated April 22, 1992, by and between, STANCHART BUSINESS CREDIT, INC., a Delaware corporation, with its business address at Suite 100, One Centerpointe Drive, Lake Oswego, Oregon 97035 ("the Lendor") and GREENBALL CORPORATION, a California corporation, with its business address at 222 S. Harbor Boulevard, Suite 700, Anaheim, California 92805 ("Borrower") recorded with the U. S. Patent and Trademark Office on March 30, 1993, and located on Reel 0979 at Frame 0283.

WHEREAS, effective April 30, 1995, the Lendor assigned all of its right, title and interest as granted under the April 22, 1992 Security Interest to Union Bank, a California corporation, with its business address at Suite 900, 70 So. WHEREAS, the assignment to the Successor Lendor of the security interest was recorded with the U.S. Patent and Trademark Office on April 17, 1995 and is located on Reel 1347 at Frame 0327; and

WHEREAS, effective May 31, 1996, the Successor Lendor assigned all of its right, title and interest as granted under the April 22, 1992 Security Interest to Union Bank of California, N.A., a National banking association, with its business address at 350 California Street, San Francisco, California 94105, (the "Second Successor Lendor"); and

WHEREAS, the assignment to the Second Successor Lendor of the security interest was recorded with the U.S. Patent and Trademark Office on June 10, 1996 and is located on Reel 1472 at Frame 0247; and

WHEREAS, Borrower has satisfied its obligations to Lendor, as provided in the Security Interest; and

WHEREAS, Second Successor Lendor is the successor to Lendor, by assignment from the Successor Lendor; and

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Second Successor Lendor hereby notifies, acknowledges to and agrees with Borrower that the security interest granted by Borrower in the Trademarks listed on the attached Schedule A, is terminated and released, and that Second Successor Lendor hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Security Interest in the Trademarks.
