RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "Release"), dated as of September 17, 2014, is made by Ares Capital Corporation, a Maryland corporation (as successor in interest to Allied Capital Corporation), as agent for the Lenders under the Credit Agreement (defined below) (in such capacity, the "Agent"). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement or Security Agreement, as applicable.

WHEREAS, in connection with that certain Credit Agreement, dated as of February 3, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and between Integrity Interactive Corporation, a Delaware corporation (now SAI Global Compliance, Inc.) (the "Grantor"), and the Agent, the Lenders agreed to make extensions of credit to Grantor;

WHEREAS, in connection with that certain Security Agreement, dated as of February 3, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") among the Grantor and Agent, the Grantor granted to the Agent, for itself and the benefit of the Lenders, certain liens on the Collateral to secure its Obligations under the Credit Agreement;

WHEREAS, in connection with the Security Agreement, and pursuant to that certain Acknowledgement of Intellectual Property Collateral Lien dated as of February 3, 2006 among the Grantor and Agent (the "Lien"), the Grantor granted a security interest in certain intellectual property owned by the Grantor, including those listed on Exhibit A attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Lien was recorded in the U.S. Patent and Trademark Office on August 1, 2006 at Reel/Frame 3359/0565;

NOW THEREFORE, the Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Lien, the Security Agreement or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Grantor.

The Agent agrees, at the expense of the Grantor, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required to effect the release of the Agent's security interests in the Intellectual Property Collateral.
