**RELEASE OF  
GRANT OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

**WHEREAS**, Team Nevada, Inc., a Delaware corporation, CTM Enterprises, Inc., a Nevada corporation, Aries Marketing, Inc., a Nevada corporation and Red Rock Sales and Marketing Co., Inc., a Nevada corporation (the "Grantors"), are the owners of the trademark registrations listed on Schedule A attached hereto (the "Trademarks");

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby release and relinquish, and hereby reassign to the Grantors, without representation or warranty, all of the Collateral Agent's right, title and interest in and to the Trademarks listed on attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Grant in the United States Patent and Trademark Office, as aforesaid, may be removed of record.
