ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, PASSAVANT MEMORIAL HOMES, a Pennsylvania non-profit corporation, PASSAVANT DEVELOPMENT CORPORATION, a Pennsylvania corporation, ACCESSIBLE DENTAL SERVICES INC., a Pennsylvania non-profit corporation, INVIVASPAN HEALTH, INC., a Pennsylvania non-profit corporation, PASSAVANT MEMORIAL HOMES FOUNDATION, a Pennsylvania non-profit corporation, PDC Pharmacy Colorado, Inc., a Pennsylvania corporation and Valley Prescription Services, Inc. , a Missouri corporation (each, a "**Grantor**" and collectively, the "**Grantors**"), each has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "**Trademarks**");

WHEREAS, the Grantors have entered into a Security Agreement, dated as of September 10, 2014, by and among the Grantors and First National Bank of Pennsylvania, as administrative agent for certain financial institutions (in such capacity, the "**Administrative Agent**") (as further amended, restated, amended and restated, supplemented or otherwise modified from time to time in accordance with its terms, the "**Security Agreement**");

WHEREAS, pursuant to the Security Agreement, the Grantors have granted to the Administrative Agent a continuing security interest in all right, title and interest of the Grantors in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "**Collateral**"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors do hereby grant to the Administrative Agent for the benefit of certain lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Grantors do hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.






