ASSIGNMENT OF TRADEMARK AND GOODWILL

This ASSIGNMENT OF TRADEMARK AND GOODWILL (hereinafter "Assignment"), is made effective as of the 18th day of September, 2014, by and between Q3 ASSET ACQUISITION, LLC, an Illinois limited liability company (hereinafter "Assignor") and QUEST PRODUCTS, INC., an Illinois corporation, (hereinafter "Assignee").

WHEREAS, Assignee desires to acquire any and all rights that Assignor may have in and to the Trademark and the registrations therefore, together with all of the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark, along with the right to recover for damages and profits for past, present and future infringement, dilution or misappropriation thereof;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assigns unto Assignee all right, title and interest in and to the Trademark and the U.S. registrations therefore throughout the United States together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark, along with all causes of action (either in law or in equity), and the right to sue, counterclaim, and recover for past, present, and future infringement, dilution or misappropriation of the Trademark, and all rights corresponding thereto throughout the United States.




