
**ASSIGNMENT OF TRADEMARK

Assignor further agrees to indemnify, defend and hold harmless Assignee against any and all claims, actions, suits, costs, royalties, expenses and damages in connection with the transfer of said Intellectual Property.

And, Assignor shall and shall cause its agents, employees, successors and assigns to execute and deliver all documents deemed be necessary or desirable to secure intellectual property protection in the Intellectual Property or other legal protection in any country or jurisdiction and to vest title in the Assignee or its nominee.
