**Assignment**

This Assignment of Trademarks ("Assignment"), effective as of June 2, 2014, is made by and between Rockies Trademark, LLC, a Colorado limited liability company, ("RTT"); and Boulder Beer, Inc., a Colorado corporation ("BBI"). RTI and BBI shall be referred to collectively as "the Parties."

**Recitals**

RTI and BBI are parties to an Asset Transfer and Distribution Agreement, effective June 2, 2014 (the "Agreement");

As part of the Agreement, RTI wishes to assign and BBI wishes to receive certain US trademark registrations as listed on Exhibit A, and all common law rights associated therewith and all goodwill identified thereby (collectively the "Trademarks");

**Agreement**

In consideration of the promises herein contained, the receipt and sufficiency of which the parties acknowledge, the Parties agree as follows:

1. RTI hereby assigns to BBI, and BBI hereby accepts, any and all rights, title and interest it may have in and to the Trademarks, and all claims for damages by reason of past, present or future infringement, dilution or misappropriation of the foregoing, with the right to sue for and collect the same.
2. This Assignment is subject to all the terms and conditions of the Agreement.
3. This Assignment may be executed in multiple counterparts and by facsimile or electronic signature, any one of which will be deemed an original, but all of which shall constitute one and the same instrument.
