8. In lieu of the Comptroller's certificate, the limited liability company as the Converted Entity will be responsible for the payment of all fees and franchise taxes.

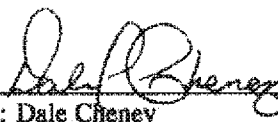
9. The conversion will become effective on August 6, 2007.

**PLAN OF CONVERSION**  
**OF**  
**NORTH AMERICAN BEVERAGES, LTD.**

1. The following are the domestic converting and converted entities that are a party to the conversion:

A. North American Beverages, Ltd., a Texas limited partnership (the "Converting Entity"); and

B. North American Beverages, LLC, a Texas limited liability company (the "Converted Entity").

2. The Converting Entity shall continue in its existence in the organizational form of the Converted Entity, which shall be a Texas limited liability company organized under the Texas Business Organizations Code.


3. Each partnership interest of the Converting Entity shall be canceled and extinguished and shall be convertible into and become a right to receive from the Converted Entity an equivalent number of membership interests in the Converted Entity as reflected in the Company Agreement of the Converted Entity. Each such membership interest shall have the value attributable to such share in the Company Agreement of the Converted Entity.
