TRADEMARK ASSIGNMENT

THEREFORE, BE IT KNOWN that for good and valuable consideration related to that certain Asset Purchase Agreement dated September 22nd 2014 ("Asset Purchase Agreement") entered into by and between Assignor and Assignee, among others, and the further consideration of one United States dollar (\$1.00), the receipt and sufficiency of such consideration and further consideration hereby being acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee, its successors and/or assigns, free and clear of all liens and encumbrances, all of Assignor's entire right, title and interest, including all common law rights that may exist therein, in and to the Assigned Trademarks and in and to any registrations, renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith and/or symbolized thereby and any right to recover for past infringement(s) thereof.

Assignor shall execute any and all further documents necessary or advisable to effectuate and record this Agreement. Assignor irrevocably designates and appoints Assignee and its duly authorized officers, members, assignees, affiliates and employees and agents as its agent and attorney-in-fact to execute and file any and all applications and other necessary documents and to do all other lawfully permitted acts to further the prosecution, issuance or enforcement of the Assigned Trademarks with the same legal force and effect as if Assignor had executed them. The laws of the United States shall govern the interpretation and enforcement of this Agreement.
