1. Name of Limited Liability Company. The name of the LLC is National Support Services (North America), LLC.

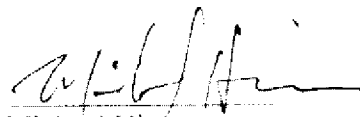
