RESTATED ARTICLES OF INCORPORATION

The undersigned certify that:

1. They are the president and secretary, respectively, of NM Productions, Inc., a California corporation.

2. Article I of the Restated Articles of Incorporation of NM Productions, Inc., filed with the Secretary of State on June 23, 1995, is amended to read as follows:

"The name of this corporation is Nightmare Productions, Inc."

3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the board of directors.

4. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is Three Thousand Seven Hundred and Fifty (3,750). The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%).
