TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“**Agreement**”) is made this June 16, 2014

Between

Genzyme Corporation a corporation with its principal place of business located at 500 Kendall St, Cambridge, Massachusetts 02142, USA,

(hereinafter referred to as the “**Assignor**”)

of the One Part;

AND

Institut Georges Lopez, a French société par actions simplifiée, with its registered office located at Route Nationale 6, Parc tertiaire du Bois Dieu, 69380 Lissieu, France,

(hereinafter referred to as the “**Assignee**”)

of the Other Part.

The Assignor and the Assignee shall individually be referred to as a “**Party**” and collectively as the “**Parties**”.

WITNESSETH:

WHEREAS, Assignor and Assignee (among others) are parties to an asset purchase agreement dated as of February 5, 2014 as amended on May 28, 2014 (the “**Asset Purchase Agreement**”), pertaining to the acquisition, by Assignee of the totality of the Transferred Assets (capitalized terms used and not otherwise defined herein shall have the meanings ascribed to them in the Asset Purchase Agreement) owned by Assignor and its Relevant Affiliates, pursuant to which Assignor assigned, and undertook to cause its Relevant Affiliates to assign, to Assignee, all of its and its Relevant Affiliates’ right, title and interest in and to the trademarks listed in the attached Schedule 1 hereinafter collectively referred to as the “**Trademarks**”), and Assignee is to purchase all of Assignor’s and its Relevant Affiliates’ right, title and interest in and to the Trademarks.

NOW THIS DEED WITNESSETH THAT for good and valuable consideration paid by the Assignee to Assignor under the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor does hereby sell, assign and transfer to the Assignee the full ownership and the entire rights, title and interest in and to the said Trademarks.

The assignment of the Trademarks shall be effective on the Effective Date. Consequently, Assignee shall, as from the Effective Date, be vested with all rights over the Trademarks and shall be entitled to assign them, use them, maintain them or abandon them as it wishes. This Agreement shall entail the right for Assignee to bring legal claims for infringement or other violation of the Trademarks in respect of all acts of infringement or other violations which are not time-barred, whether occurring prior to or after the Effective Date. This Agreement shall also entail all rights for the Assignee to claim priority or seniority from the Trademarks.

The warranties expressly set forth in the Asset Purchase Agreement in respect of the Trademarks are the exclusive warranties given in connection with the sale and transfer of the Trademarks. In the event of any breach of such warranties, the Assignee shall be entitled to claim indemnification from Genzyme Polyclonals SAS in accordance with the provisions of the Asset Purchase Agreement.

Further undertakings

The Assignee shall be responsible for, and shall pay all expenses related to the maintenance of the Trademarks with respect to the period beginning on and after the Effective Date. If, during the six (6) month period after the Effective Date, any of the Trademarks comes up for renewal before the change in ownership has been effectively recorded, the Assignor shall, at the request and expense of Assignee, carry out the necessary formalities. If the Assignor receives after the Effective Date any bills or invoices for expenses related to the maintenance of the Trademarks after the Effective Date, then the Assignor shall promptly forward to the Assignee such bills or invoices for payment by the Assignee.

The Assignor shall deliver up, or make available to Assignee or its designee, within 30 calendar days from the date of a written request to this effect from the Assignee, the following items:

- Originals of all registration and renewal certificates for the Trademarks and, if no registration has yet been granted, the application receipts;
- Originals (or, if not available, copies) of all documents concerning all previous transfers of ownership of the Trademarks;
- Copies of all correspondence, evidence and legal advice which concerns any ongoing matters relating to the Trademarks;
- Details of agents in charge of handling the Trademarks in each jurisdiction where the Trademarks are registered or applied for.

The registration of this Agreement with the relevant national Governmental Authorities, if required, shall be undertaken, if and when applicable, by the Assignee who shall bear all costs and fees in connection therewith.

Further Assurances

The Assignor on the one hand and the Assignee on the other, shall, and shall use reasonable endeavours to procure that any necessary third party shall, from time to time, execute such documents and perform such acts and things in a timely manner as either one of the Assignor or the Assignee may reasonably require at the cost of the Assignee to give each of them the full benefit of this Agreement.

In particular, in compliance with Article 7.2.6 of the Asset Purchase Agreement, the Assignee shall be responsible for, and shall pay all expenses (whether incurred before or after the Effective Date) involved in notarization, authentication, legalization and/or consularization of the signature of Assignee's representatives on this Agreement, as well as on the trademark assignment documents by country, and recording such assignment documents with the appropriate Governmental Authorities. Assignee shall provide standard form assignment documents by country, at Assignee's expense, for approval, which shall not be unreasonably withheld and execution by Assignors. For all assignment documents received from Assignee within a period of six (6) month from the Effective Date, the Assignor shall be responsible for, and shall pay all expenses (whether incurred before or after the Effective Date) involved in notarization, authentication, legalization and/or consularization of the signatures of Assignor's representatives on all assignment documents.

After the expiry of the six (6) month period, the Assignor shall, at the reasonable request and cost of Assignee, execute any further documents that may be necessary to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder.

Whole Agreement

The Parties acknowledge and confirm that this Agreement and the Asset Purchase Agreement contain the whole and entire agreement between the Parties, to the exclusion of any terms implied by law which may be excluded by contract and supersedes any previous written or oral agreement between the Parties. To the extent any provision of this Agreement is inconsistent with the provisions of the Asset Purchase Agreement, the provisions of the Asset Purchase Agreement shall prevail.

Amendment; Waiver

This Agreement may only be amended, supplemented or modified and any provision of this Agreement may only be waived, pursuant to a written instrument making specific reference to this Agreement and executed by duly authorized representatives of the Parties.

Severability

This Agreement shall be deemed severable, and the invalidity or unenforceability of any term or provision hereof shall not affect the validity or enforceability of this Agreement or of any other term or provision hereof. Furthermore, in lieu of any such invalid or unenforceable term or provision, the Parties intend that there shall be added as a part of this Agreement a provision as similar in terms to such invalid or unenforceable provision as may be possible and be valid and enforceable.

Notices

All notices and other communications under this Agreement shall be in writing and in English language and shall be deemed to have been duly given when delivered in person or upon confirmation of receipt when transmitted by facsimile transmission or on receipt after dispatch by registered or certified mail, postage prepaid, addressed as follows (or at such other address as the Party to whom notice is to be given has furnished in writing to the other Party):

Costs

- (a) Except as otherwise provided in this Agreement or in the Asset Purchase Agreement, each Party shall be responsible for its own costs, charges and other expenses (including those of its Affiliates) incurred in connection with the Agreement and implementation of its provisions.
- (b) The Assignee shall bear the stamp duty and any value added tax, if applicable, in any jurisdiction in any of the Product Territories, arising in connection with this Agreement or arising from the assignment of the Trademarks to the Assignee.

Arbitration

All disputes arising in connection herewith shall be finally settled under the Rules of Conciliation and Arbitration of the International Chamber of Commerce ("ICC") as in effect as of the date of commencement of the arbitration proceedings, by three (3) arbitrators. The arbitration proceeding shall take place in Paris (France) and shall be conducted in the English language. The arbitration decision shall be binding upon the Parties and judgment upon any award rendered may be entered in any court having jurisdiction.

Governing Law

This Agreement shall be governed in all respects by the laws of France, including validity, interpretation and effect, without regards to the principle of conflicts of laws that might otherwise be applicable.

Headings

The descriptive headings of the several sections and Schedules of this Agreement are inserted for convenience only and do not constitute a part of this Agreement, and in no way define, limit or describe the scope or intent of this Agreement or any of the provisions hereof.




