

Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Service Mark.

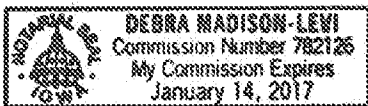
