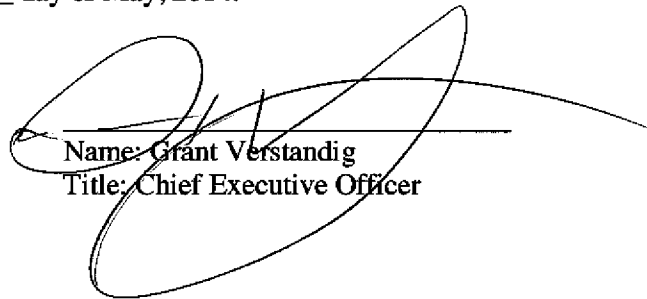
**CERTIFICATE OF CONVERSION
