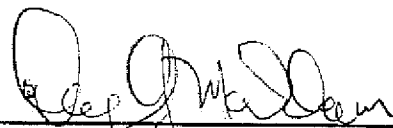
1. They are the **president** and the **secretary**, respectively, of WellComp Managed Care Services, Inc., a California corporation.

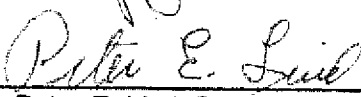
