## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 19, 2014 (this “Release”), is made by ROYAL BANK OF CANADA (the “Assignor”), in favor of CASCO PRODUCTS CORPORATION and ARC AUTOMOTIVE, INC. (collectively, the “Assignees”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

### WITNESSETH

WHEREAS, the Assignees and the Assignor entered into that certain Trademark Security Agreement, dated as of November 15, 2012 (the “Security Agreement”), pursuant to which the Assignees pledged, assigned and granted to the Assignor for the benefit of the Secured Parties a security interest, in all right, title or interest in or to any and all of the Trademark Collateral owned by such Assignees including, without limitation, the trademarks and trademark applications listed in Schedule A hereto (collectively, the “Collateral”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on September 6, 2013 at Reel/Frame No. 5106/0591;

WHEREAS, the Assignees request a specific release of the security interest granted and recorded against the Collateral; and


WHEREAS, the Assignor has agreed to release its security interest in the Collateral and re-assign and transfer all of its right, title and interest in the Collateral to the Assignees.
