Pursuant to Section 10-2B-11.05 of the Alabama Business Corporation (the "Act"), the undersigned, being an Alabama corporation and the surviving entity of this merger, hereby submits these Articles of Merger, as follows:

1. Effective Date of Merger. This merger shall be effective upon the filing of these Articles of Merger in the Office of the Secretary of State of the State of Alabama. For accounting purposes, however, the merger shall be deemed effective as of the close of business on April 30, 2007.

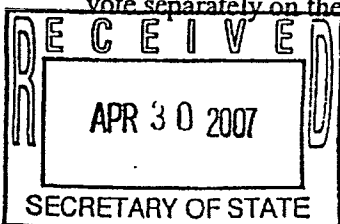
2. Merging Corporations. The name of each corporation which is to merge, the county where the Articles of Incorporation of each such corporation are filed, and the date of such filing are as follows:

King Kutter, Inc. ("Merging Corporation")	Fayette County, Alabama May 5, 1978
Taylor Pittsburgh Manufacturing, Inc. ("Surviving Corporation")	Marion County, Alabama February 5, 2001

3. Plan of Merger. The Agreement and Plan of Merger, setting forth the provisions of the plan of merger as required by Section 10-2B-11.01 of the Act, is attached hereto as Exhibit "1" and made a part hereof by reference and adoption (hereinafter referred to as the "Plan of Merger").

4. Surviving Corporation. Taylor Pittsburgh Manufacturing, Inc. shall be the surviving corporation of this merger and, as set forth in the Plan of Merger, shall change its name to King Kutter, Inc. effective with the filing of these Articles of Merger.

5. Outstanding Shares and Approval of Plan of Merger. The designation, number of outstanding shares and number of votes entitled to be cast by each voting group entitled to vote separately on the Plan of Merger for each of the constituent corporations are as follows:
