TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of the date listed below (the "Effective Date"), by and between GARNET VINEYARDS, LLC, a California limited liability company, having offices at 855 Bordeaux Way, Suite 100, Napa, California 94558 ("Assignor") and BARREL TEN QUARTER CIRCLE LAND COMPANY, INC., a California corporation, having offices at 6342 Bystrum Road, Ceres, California 95307 ("Assignee"). Assignor and Assignee are sometimes collectively referred to herein as the "Parties."

RECITALS

A. Assignor is the owner of the trademark GARNET, U.S. Trademark Registration No. 1,669,670, in International Class 033 for Wine (the "Trademark").

B. Pursuant to the Parties' Purchase Agreement of this date, Assignee is desirous of acquiring, and the Parties have agreed to assign, 50% ownership of said Trademark.

NOW, THEREFORE, incorporating the Recitals, and in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignor hereby irrevocably assigns, grants, conveys and transfers to Assignee a Fifty Percent (50%) interest in and to the Trademark, (including, but not limited to, a Fifty Percent (50%) interest in and to the goodwill of the Assignor's business connected with the use of and symbolized by the Trademark, and a Fifty Percent (50%) interest in and to all registration rights with respect to the Trademark).

2. The terms of this Assignment shall bind and inure to the benefit of the Parties hereto and their respective heirs, legal representatives, successors and assigns.

3. The Parties hereby agree to do the following: execute such other documents and perform such other acts as may be necessary or desirable to carry out the purposes of this Assignment.

4. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.




