TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARK RIGHTS, dated as of September  
23, 2014 (this “**Termination and Release**”), by CREDIT SUISSE  
AG, as Administrative Agent (as defined below). Capitalized terms  
used herein and not otherwise defined shall have the meanings  
assigned to such terms in the Credit Agreement or the Security  
Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of September 22, 2010 (as amended, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among Visant Secondary Holdings Corp. (“**Holdings**”), Visant Corporation (the “**Borrower**”), Jostens Canada Ltd. (“**Jostens Canada**”), the lenders from time to time party thereto (the “**Lenders**”), Credit Suisse AG, as administrative agent (in such capacity, the “**Administrative Agent**”) and Credit Suisse AG, Toronto Branch, as Canadian administrative agent, (ii) the Security Agreement dated as of September 22, 2010 (as amended, supplemented or otherwise modified from time to time, the “**Security Agreement**”), among Holdings, the Borrower, the subsidiaries of Holdings party thereto (the “**Subsidiary Grantors**” and, together with Holdings and the Borrower, the “**Grantors**”) and the Administrative Agent and (iii) the Trademark Security Agreement dated September 22, 2010 (the “**Trademark Security Agreement**”), among the Grantors and the Administrative Agent (such documents set forth in clauses (i) through (iii), the “**Security Agreements**”).

B. Pursuant to the Security Agreements the Grantors granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in certain collateral, including the trademarks of the Grantors set forth on Schedule I hereto (the “**Trademarks**”), which security interest was recorded with the United States Patent & Trademark Office on October 12, 2010 at Reel/ Frame 004294/0632.

C. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Credit Documents, the Grantors have informed the Administrative Agent of their desire to obtain the release of all right, title and interest of the Administrative Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all of the Administrative Agent’s right, title and interest (including, without limitation, security interests) in and to the Trademarks shall hereby automatically terminate as provided in the Security Agreements, and the Administrative Agent hereby terminates, releases and discharges its security interests in the Trademarks.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.



THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY  
AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF  
NEW YORK AND SHALL BE BINDING UPON THE ADMINISTRATIVE AGENT'S  
REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
