WHEREAS, ASSIGNOR has acquired and used the following mark, as identified in the following federal trademark registration on file in the U.S. Patent and Trademark Office (the “Mark”):

WHEREAS, ASSIGNOR executed an Assignment of Mark for the Mark dated as of February 1, 2013, to Flambeau River Papers, Inc., a Wisconsin corporation, which Assignment of Mark (“2/1/13 Assignment”) was filed with the United States Patent and Trademark Office on February 13, 2013 (see attached Exhibit A).

WHEREAS, the 2/1/13 Assignment contained a typographical error listing Flambeau River Papers, Inc., a Wisconsin corporation as the ASSIGNEE instead of the correct entity, Flambeau River Papers, LLC, a Wisconsin limited liability company.

WHEREAS, the purpose of this Assignment is to correct the typographical error and name ASSIGNEE, Flambeau River Papers, LLC as the owner of the Mark.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby mutually acknowledged, the parties hereto agree as follows:

Subject to the terms and conditions set forth in the Purchase Agreement, (a) ASSIGNOR hereby sells, assigns, and transfers to ASSIGNEE all of its rights, title and interest in and to the Mark, including all goodwill expressly associated with and symbolized by the Mark and any right to sue for and receive all damages accruing from past infringement thereof; and (b) ASSIGNEE hereby accepts the foregoing assignment and assumes such rights, title and interest.
2. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and permitted assigns.

3. This Assignment, together with the Purchase Agreement, sets forth the entire agreement between the parties hereto and supersedes all prior agreements, written or oral, concerning the subject matter herein, and there are no oral understandings, statements or stipulations bearing upon the effect of this Assignment which have not been incorporated herein. In the event of any conflict between the Purchase Agreement and this Assignment, the provisions of the Purchase Agreement shall govern with respect to such conflict.






