THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of September 23, 2014, from WELLS FARGO BANK, NATIONAL ASSOCIATION (the "*Lender*") pursuant to a Notice and Confirmation of Grant of Security Interest in Trademarks (the "*Security Agreement*") dated as of November 16, 2012 between BR HYDRIVE, LLC, a Texas limited liability company (the "*Grantor*"), and the Lender.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by the Grantor to the Lender in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 19, 2012 at Reel 4903, Frame 0682; and

WHEREAS, the Lender now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:


1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I hereto.

2. Release of Security Interest. The Lender hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
