RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of September 26, 2014 ("Effective Date") by FCC, LLC d/b/a First Capital, a Florida limited liability company ("Lender"), in favor of Riverside Manufacturing Company, a Georgia corporation, Riverside Industries, Inc., a Georgia corporation, Riverside Manufacturing Company D.R., a Georgia corporation, and Uniform Property Holdings, L.L.C., a Georgia limited liability company (each a "Borrower"; collectively, the "Borrowers").

WHEREAS, pursuant to the terms and conditions of that certain Notice of Grant of Security Interest in U.S. Trademarks by and between Borrowers and Lender dated as of April 30, 2013 (the "Trademark Security Agreement"), each Borrower granted to Lender a continuing security interest in and to all of such Borrower's right, title and interest in and to all of the trademarks set forth on Schedule A attached hereto (collectively, the "Trademarks");

WHEREAS, Borrowers and Lender entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Borrowers and Lender dated as of April 30, 2013 (the "Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on May 2, 2013 at Reel/Frame 5020/0130; and


WHEREAS, Lender has agreed to terminate and release its security interest and all of its right, title and interest in each of the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates and releases its security interest in and lien on the Trademarks, and Lender hereby assigns and transfers to Borrowers, without recourse, all of Lender's right, title and interest in and to each of the Trademarks.
