
WHEREAS, Assignee wishes to acquire all of Assignor's right, title and interest in and to the Registration and the Mark;

Assignor covenants and agrees that it will execute all further documents and authorizations and take all other actions that may be necessary or required to effectuate the assignment herein.

IN WITNESS WHEREOF, Assignor has caused this Trademark Assignment to be duly signed and authorized as of the date written above.

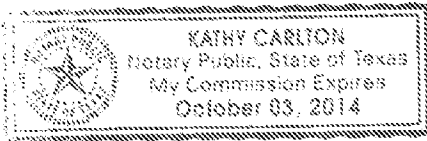
