**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 29, 2014 (“Release”), is made by **Citibank, N.A.**, a national association with offices at 1615 Brett Road, Ops III, New Castle, Delaware 19720, as successor to Citicorp USA, Inc., as Administrative Agent (“Administrative Agent”), in favor of **Minnesota Wild Hockey Club, LP**, a Minnesota limited partnership (“Teamco”), **Saint Paul Facilities Management, LLC**, a Minnesota limited liability company (“SPFM”), and **Saint Paul Arena Company, LLC**, a Minnesota limited liability company (“SPAC”), **Minnesota Hockey Ventures Group, LP**, a Minnesota limited partnership (“MHVG”), **NS Holdings, LLC**, a Minnesota limited liability company (“NSH”), **MSE Holdings, LP**, a Minnesota limited partnership (“MSE”), and **Aeros Hockey Club, LLC**, a Minnesota limited liability company (“Aeros” and, together with Teamco, SPFM, SPAC, MHVG, NSH, and MSE, the “Debtors”), each with offices at 317 Washington Street, Saint Paul, Minnesota 55102.

WHEREAS, pursuant to those certain Security Agreements dated as of April 11, 2008 and April 4, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreements”) and the Notices of Security Interest in Intellectual Property – Trademarks, also dated as of April 11, 2008 and April 4, 2013 (“Notices”), each by and among the Debtors and the Administrative Agent, the Debtors granted to the Administrative Agent a continuing security interest in the Debtors’ trademarks, including, but not limited to, those listed on Schedule A attached hereto (the “Trademarks”); and

WHEREAS, the Notices were recorded with the United States Patent and Trademark Office (“USPTO”) and the Canadian Intellectual Property Office (“CIPO”) including, without limitation, with the USPTO at Reel/Frame 3761/0284 and Reel/Frame 5051/0074, and with the CIPO under File No. 859374; and

WHEREAS, the Administrative Agent desires to terminate all such security interests, and to execute and deliver to the Debtors all deeds, assignments and other instruments as may be reasonably necessary to release the security interests relating to the Trademarks.


