**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of September 30, 2014, is made by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent (the "Administrative Agent") pursuant to the Credit Agreement, dated as of March 28, 2013 (the "Credit Agreement") and the Guaranty and Security Agreement, dated as of March 28, 2013 (the "Guaranty and Security Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Guaranty and Security Agreement.

**W I T N E S S E T H**

WHEREAS, AVI Rental Services Division, L.L.C. (the "Grantor") is party to the Credit Agreement and the Guaranty and Security Agreement;

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantor executed (i) the Trademark Security Agreement dated March 28, 2013 and recorded with the U.S. Patent and Trademark Office on March 28, 2013 at Reel/Frame No. 4993/0909 (the "Trademark Security Agreement"), pursuant to which the Grantor granted to the Administrative Agent for the benefit of the Secured Parties a security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), and (ii) the Copyright Security Agreement dated March 28, 2013 and filed with the U.S. Copyright Office for recordation on March 29, 2013 (the "Copyright Security Agreement"), pursuant to which the Grantor granted to the Administrative Agent for the benefit of the Secured Parties a security interest in, all of its right, title and interest in, to and under the Copyright Collateral (as defined in the Copyright Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

The Administrative Agent hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Credit Agreement, Guaranty and Security Agreement, Trademark Security Agreement, Copyright Security Agreement, or otherwise, in and to the trademark and copyright registrations listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral").


