NOW, THEREFORE, for good and valuable consideration, the premises and the mutual covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby unconditionally and irrevocably assign, transfer, convey and deliver unto Assignee all of Assignor's right, title and interest in the Marks, together with the common law rights, registrations, applications, designs, models, forms of property protection, and the goodwill of the business symbolized by all of the foregoing, including, but not limited to, the right to sue for past infringement by third parties, and the right to register and use the Marks without limitation.




