


**PURSUANT TO SECTION 1401 OF THE
UTAH REVISED LIMITED LIABILITY COMPANY ACT**

1. The jurisdiction where the corporation was first formed is New York.
2. The jurisdiction immediately prior to the filing of these Articles of Conversion is Utah.
3. The date the corporation was first formed is August 18, 1992.
4. The name of the corporation immediately prior to the filing of these Articles of Conversion is "School Improvement Network, Inc."
5. The name of the limited liability company as set forth in the Articles of Organization is "School Improvement Network, LLC".
