RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE, dated as of September 29, 2014, is made by Citibank, N.A., a national association ("Citibank"), in favor of St. Louis Blues Hockey Club, L.P. ("Borrower") as follows:

WHEREAS, St. Louis Blues Hockey Club, L.P. is a Missouri limited partnership with offices at 1401 Clark Avenue, St. Louis, Missouri 63103 ("St. Louis Blues Hockey");

WHEREAS, Citibank, N.A., a national association ("Citibank"), is the holder of a security agreement granting a security interest in certain trademarks dated May 9, 2012 and recorded in the U.S. Patent and Trademark Office ("USPTO") on May 11, 2012, at reel/frame number 4778/0100 (the "Security Agreement"); and


WHEREAS, Citibank desires to terminate, cancel, discharge, and release its security interest in all of Borrower's right, title and interest in the Trademark Collateral, and to execute and deliver to St. Louis Blues Hockey all deeds, assignments and other instruments as may be reasonably necessary to release the security interest relating to the trademarks set forth in the Security Agreement, which trademarks include those identified on Schedule A annexed hereto and made a part hereof (the "Trademarks").

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Citibank hereby relinquishes unto St. Louis Blues Hockey the continuing security interest in and lien on the Trademarks and otherwise assigns, grants and conveys to St. Louis Blues Hockey any and all rights Citibank may have in or to the Trademarks in order to revest in St. Louis Blues Hockey full and unencumbered title to said Trademarks.
