RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is dated as of October 2, 2014 by PACIFIC WESTERN BANK, a California state-chartered bank (as successor-by-merger to CapitalSource Bank), as administrative agent for itself and certain lenders ("Administrative Agent"), in favor of NOVETTA, INC. WHEREAS, the Administrative Agent desires to terminate and release the Security Interest in the IP Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

Capitalized terms used herein but not otherwise defined here shall have the meanings as given to such terms in the Security Agreement.

The Administrative Agent, on behalf of itself and the Lenders, hereby terminates, releases and forever discharges the Security Interest in the IP Collateral, and retransfers and reassigns to the Grantors, without representation or warranty of any kind, express or implied, free and clear of any claims by Administrative Agent, all right, title or interest of the Administrative Agent and the Lenders in, to or under the IP Collateral.
