RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of September 19, 2014 (this "Release") is made by Comerica Bank, a Texas banking association (the "Secured Party"), under the Intellectual Property Security Agreement dated as of June 24, 2013 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Noetix Corporation, a Washington corporation (the "Debtor") and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 5077, Frame 0554.

WHEREAS, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtor's trademarks, including but not limited to the trademarks listed on attached Exhibit A and the goodwill associated therewith (the "Trademarks").

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Debtor; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
