TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement, dated as of this 23d day of September, 2014, is made by Lighthouse Management Group, Inc., a Minnesota corporation, solely in its capacity as the assignee from CM Companies, LLC (in such capacity, the "Assignor"), in favor of Haramaki Holdings Limited ("Assignee"), the purchaser of certain assets of Assignor pursuant to a Purchase Agreement between Assignor and Assignee, dated as of July 2, 2014 ("PA").

WHEREAS, Assignor and Assignee have entered into the PA, under which Assignor sold, transferred, assigned and conveyed to Assignee certain intellectual property and agreed to execute and deliver this assignment for recording with governmental authorities, including the U.S. Patent and Trademark Office.

NOW, THEREFORE, for and in consideration for the execution of the PA, the payment of the consideration stipulated in the PA and other good and valuable consideration, the receipt and sufficiency of which we hereby acknowledged, and in all cases subject to the terms and conditions of the PA, Assignor hereby sells, transfers, assigns and conveys to Assignee, its successors and assigns, its entire right, title and interest in and to the Marks, provided that, with respect to the United States intent-to-use trademark applications set forth in Exhibit A hereto, the transfer of such applications accompanies, pursuant to the PA, the transfer of Assignor's business, or portion of the business to which the trademark pertains, and that business was ongoing and existing at the time of transfer, the goodwill of the business associated with the Marks, all rights to seek and collect damages and other relief for past and future infringements and all proceeds thereof and all other rights and proceeds associated therewith. The parties acknowledge and agree that the representation, warranties, covenants, agreements and indemnities contained in the PA are not superseded hereby but shall remain in full force and effect to the full extent provided therein.

Assignor and Assignee hereby authorize attorneys Fredrikson & Byron, P.A., 200 South Sixth Street, Suite 4000, Minneapolis, Minnesota, 55402-1425, to insert on Schedule A hereto the trademark registration and/or application number, filing/issue date of same, and mark of any trademark registrations and/or applications which become known after the signing of this Assignment.
