
CERTIFICATE OF CONVERSION

I HEREBY CERTIFY, That **Bank SNB, National Association**, a national banking association organized under the laws of the United States of America, whose previous business location was 608 South Main Street, Stillwater, Oklahoma, obtained the approval of the Oklahoma State Banking Board on **September 24, 2014**, to convert to a state chartered bank, under the name of **Bank SNB**, pursuant to Title 6 of the Oklahoma Statutes, Section 1107 and Banking Board Rule 85:10-3-17.
