WHEREAS, Assignor is the owner of the following mark: TURKEY THUG (and design), federal trademark registration number 3,877,823 (the "Mark"); and


WHEREAS, Assignor wishes to assign all of Assignor's right, title and interest in the Mark to Assignee; and


