GRANT OF SECURITY INTEREST

WHEREAS, Renda Broadcasting Corporation, a Pennsylvania corporation with an address at 900 Parish Street, Pittsburgh, PA 15220 (herein referred to as "Debtor") owns all right, title and interest in and to certain U.S. trademarks, including all rights in the trademarks listed on the annexed Schedule A (the "Trademarks");

WHEREAS, Debtor is obligated to Manufacturers and Traders Trust Company as Agent for certain Secured Parties (hereinafter referred to as "Agent") pursuant to a Credit Agreement dated as of September 30, 2014 (as the same may be amended, supplemented or otherwise modified from time to time, the "Agreement") in favor of the Agent; and

WHEREAS, pursuant to the Agreement, Debtor granted to Agent a security interest in all right, title and interest of Debtor in and to, among other things, the Trademarks, including the applications and registrations thereof, together with the goodwill of the business connected with the use of and symbolized by the trademarks and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations, as defined in the Agreement;

WHEREAS, this Agreement will be filed with the United States Patent and Trademark Office to among other things indicate that Agent is collateral assignee with respect to the Marks (as defined herein) listed on Exhibit 1 hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Debtor does hereby grant to Agent a security interest in the Collateral to secure the prompt payment, performance and observance of its security obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral made and granted hereby are fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. Debtor hereby agrees that, notwithstanding anything herein to the contrary, Debtor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with the Collateral subject to a security interest hereunder.


