RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of October 2, 2014, in favor of Mariani Packing Co., Inc. (the "Grantor") by Wells Fargo Bank, National Association (the "Bank").

WHEREAS, the Grantor entered into that certain Credit Agreement, dated as of October 3, 2011 (as amended, restated, supplemented or otherwise modified from time to time, being hereinafter referred to as the "Credit Agreement"), with the Lenders party thereto, the Bank and the other credit parties party thereto (the "Credit Parties");

WHEREAS, in connection with the Credit Agreement, the Grantor assigned to the Bank (the "Assignment") an interest in certain trademark collateral (as set forth on Schedule A hereto) (the "Trademark Collateral");

WHEREAS, the Assignment was recorded by the United States Patent and Trademark Office on September 18, 1995 at Reel 1391 and Frame 0539, and on June 30, 1997 at Reel 1602 and Frame 0606; and

WHEREAS, the Grantor and Credit Parties have paid in full all of the outstanding monetary obligations under the Credit Agreement and request a specific release of the security interest granted and recorded against the Trademark Collateral, and Bank agrees to release, relinquish and discharge all of its right, title and interest in and to the Trademark Collateral, including without limitation, all of the trademarks set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank, on behalf of itself and the Lenders, hereby agrees as follows:

1. The Bank hereby terminates, relinquishes, releases and discharges in its entirety the Bank's lien on and security interest in the Trademark Collateral, including, but not limited to, all of the trademarks set forth on Schedule A hereto. If and to the extent the Bank retains any interest in the Trademark Collateral, the Bank hereby assigns, transfers and conveys to the Grantor, all of the Bank's right, title and interest, now owned or hereinafter acquired, that the Bank may have whether by assignment or otherwise, in and to the Trademark Collateral.

2. The Bank hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or required in order to evidence the release of such interest and/or more fully and effectively carry out the purposes of this Release at the Grantor's sole cost and expense.

3. The Bank hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government agency record this Release.

4. This Release shall be governed by and construed in accordance with the laws of the State of New York.
