## TRADE-MARK ASSIGNMENT AGREEMENT

This Trade-mark Assignment (the "**Assignment**") by PRIVAX INTERNATIONAL LIMITED, a corporation incorporated under the laws of Canada, having its principal place of business at 1005 Skyview Drive, Suite 104, Burlington, Ontario, L7P 5B1, (the "**Assignor**") to SAVARIA HOME ACCESS INC., a corporation incorporated under the laws of Ontario, having its registered office at 2 Walker Drive, Brampton, Ontario, L6T 5E1, (the "**Assignee**"), is effective as of September 11, 2014.

The Assignor desires to assign to the Assignee, and the Assignee desires to acquire from the Assignor, all of the Assignor's right, title and interest in and to the registered Trade-marks set forth in Schedule A hereto (the "**Trade-marks**"), together with the business of the Assignor to which said Trade-marks pertain.

NOW, THEREFORE, in consideration for the amounts paid under the Asset Purchase Agreement among Privax International Limited, Privax (Canada) Inc., Privax (USA) Inc., Savaria Corporation and the Assignee, dated September 11, 2014, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. The Assignor hereby grants, assigns and conveys to the Assignee, and its successors and assigns, all of its right, title and interest in and to the Trade-marks.
2. Cooperation. The Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may reasonably be requested by the Assignee to effectuate more fully the transactions contemplated by this Assignment.
3. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of the Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
5. Governing law. This Agreement shall be construed in accordance with the law of the Province of Ontario.


