**TERMINATION AND RELEASE OF  
GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (SECOND LIEN)**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of October 7, 2014, and made by Barclays Bank PLC, a private limited company, as administrative agent, having an office at 745 Seventh Avenue, New York, New York 10019 ("Barclays") to Grocery Outlet Inc., a California corporation, whose principal place of business is 2000 Fifth Street, Berkeley, California 94710 (the "Grantor").

WHEREAS, pursuant to a Second Lien Trademark Security Agreement, dated as of December 17, 2012, made by the Grantor in favor of Barclays, certain security interests (the "Interests") were granted by the Grantor to Barclays in certain collateral, including (a) the Trademarks of the Grantor listed on Schedule I attached thereto (and included on Schedule A attached hereto), (b) all goodwill associated with such Trademarks, and (c) all Proceeds of any and all of the foregoing (other than Excluded Property (as defined in the Second Lien Credit Agreement, dated as of December 17, 2012, made by and among GOBP Midco, Inc., the Grantor, the lenders party thereto from time to time and Barclays) (collectively, the "Trademark Collateral");

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office on December 19, 2012, at Reel 4922 and Frame 0983;

WHEREAS, Barclays now desires to terminate and release the Interests; and

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral, Barclays hereby states as follows:

1. Definitions. Capitalized terms used herein without definition are used as defined in the Second Lien Guarantee and Collateral Agreement, dated as of December 17, 2012, made by, *inter alios*, the Grantors in favor of Barclays.

2. Release of Security Interest. Barclays hereby terminates the Interests and terminates, releases and discharges its interest in the Trademark Collateral, without recourse, representation or warranty, and any right, title or interest of Barclays in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. Barclays hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Interests contemplated hereby.
