**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”), dated as of October 1, 2014, is made by General Electric Capital Corporation, in its capacity as administrative agent for the Lenders, the L/C Issuers and the other Secured Parties (in such capacity, the “Administrative Agent”), in favor of WELLCOMP MANAGED CARE SERVICES, INC., a Texas corporation (“WMCS”), FOX HILL HOLDINGS INC., a Delaware corporation (“Fox Hill”), F.A. RICHARD & ASSOCIATES INC., a Louisiana corporation (“FR&A”), NATIONAL EMPLOYERS NETWORK ALLIANCE, INC. (“NAEA”), ROCKPORT COMMUNITY NETWORK, INC., a Nevada corporation (“Rockport”), THE FRANK GATES COMPANIES, INC., an Ohio corporation (“FGC”), THE FRANK GATES SERVICE COMPANY, an Ohio corporation (“FGCS”), VISUAL RISK SOLUTIONS, INC., an Ohio corporation (“VRS”), CAREWORKS LTD., an Ohio limited liability company (“Careworks”), CAREWORKS OF OHIO LTD., an Ohio limited liability company (“Careworks Ohio”), CAREWORKS TECHNOLOGIES LTD., an Ohio limited liability company (“Careworks Tech”), Riskcontrol 360, LLC, an Ohio limited liability company (“Riskcontrol”) and BICKMORE (f/k/a Bickmore and Associates, Inc.), a California corporation (“Bickmore” and, collectively with WMCS, Fox Hill, FR&A, NAEA, Rockport, FGC, FGCS, VRS, Careworks, Careworks Ohio and Careworks Tech, “Grantors” and each, a “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the 2010 Security Agreement (as defined below), the 2011 Security Agreement (as defined below), the January 2014 Security Agreement (as defined below) or the May 2014 Security Agreement (as defined below), as applicable.

**WITNESSETH**

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 28, 2010 (the “2010 Security Agreement”), each of WMCS and Fox Hill, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Grantor, mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth on Schedule A (the “2010 Trademark Collateral”);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 15, 2011 (the “2011 Security Agreement”), each of WMCS, Fox Hill, FR&A, NAEA, Rockport, FGC, FGCS and VRS, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of its Secured Obligations, mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth on Schedule B (the “2011 Trademark Collateral”);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of January 31, 2014 (the "January 2014 Security Agreement"), each of Careworks, Careworks Ohio, Careworks Tech and Risk Control, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of its Secured Obligations, mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth on Schedule C (the "January 2014 Trademark Collateral");

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 1, 2014 (the "May 2014 Security Agreement" and, collectively with the 2010 Security Agreement, the 2011 Security Agreement and the January 2014 Security Agreement, the "Security Agreements"), Bickmore, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of its Secured Obligations, mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth on Schedule D (the "May 2014 Trademark Collateral" and, collectively with the 2010 Trademark Collateral, the 2011 Trademark Collateral and the January 2014 Trademark Collateral, the "Trademark Collateral");

WHEREAS, the 2010 Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on December 28, 2010 at Reel/Frame 4441/0678;

WHEREAS, the 2011 Security Agreement was recorded with the USPTO on December 15, 2011 at Reel/Frame 4680/0143;

WHEREAS, the January 2014 Security Agreement was recorded with the USPTO on January 31, 2014 at Reel/Frame 5205/0381;

WHEREAS, the May 2014 Security Agreement was recorded with the USPTO on May 1, 2014 at Reel/Frame 5272/0241; and

WHEREAS, Grantors have requested that the Administrative Agent release its security interest in all right, title and interest of the Administrative Agent in the Trademark Collateral and reconvey any and all rights it may have in the Trademark Collateral to Grantors.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged:

SECTION 1. The Administrative Agent hereby: (i) terminates, cancels, discharges, and releases its security interest in, to and under all of all of Grantors' right, title and interest in, to

and under the Trademark Collateral; and (ii) assigns to Grantors any and all interest it may have in such Trademark Collateral.

SECTION 2. The Administrative Agent hereby authorizes Grantors, or Grantors' authorized representatives to: (a) record this Release with USPTO and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Administrative Agent in the Trademark Collateral. The Administrative Agent agrees to execute, acknowledge and deliver any additional documents or instruments and take any additional actions necessary or as may be necessary to effect, record and perfect the release of the Administrative Agent's security interest in the Trademark Collateral which had been granted under the Security Agreements.
