RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is granted and conveyed as of October 7, 2014 by and among CapitalSource Business Finance Group, a dba of BFI Business Finance ("Secured Party"), a California corporation having a business address at 851 East Hamilton Avenue, 2nd Floor, Campbell, CA 95008, in favor of AutoEdge Distribution, Inc., a California corporation having a business address at 2425 La Mirada Drive, Vista, CA 92081 ("Pledgor").

WHEREAS, Secured Party and Pledgor entered into an Intellectual Property Security Agreement, dated as of November 27, 2007 (the "Security Agreement"), pursuant to which Pledgor granted to Secured Party a lien and security interest in all of Pledgor's present and future right, title and interest in and to certain of Pledgor's trademarks, including all of those marks identified on Exhibit A (the "Trademarks"), together with all the goodwill of Pledgor associated with and represented by the Trademarks, and the registration thereof and the right (but not the obligation) to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits (collectively, the "Trademark Collateral").

WHEREAS, the United States Patent and Trademark Office recorded the Security Agreement against the Trademark Collateral at Trademark Reel 3676/ Frame 0290 on December 11, 2007.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Secured Party hereby releases, discharges, and relinquishes all security interests granted pursuant to the Security Agreement with respect to all of the Trademarks and the Trademark Collateral related or associated with such Trademarks. Secured Party specifically acknowledges that all such security interests are no longer effective, and that Secured Party does not own any rights to or have any ownership interest in the Trademarks and the Trademark Collateral related or associated with such Trademarks.
