RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST is made effective as of September 29, 2014, by and from GENERAL ELECTRIC CAPITAL CORPORATION, for itself and as Administrative Agent for the Secured Parties (the "Administrative Agent") to SPEAR USA INC., an Ohio corporation (the "Grantor") as follows:

WHEREAS, on August 19, 2011, the Grantor, certain Subsidiaries and Affiliates of the Grantor and JPMorgan Chase Bank, N.A. (the "Initial Administrative Agent") entered into a Pledge and Security Agreement (the "Security Agreement") and the Grantor and Initial Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, pursuant to the Security Agreement and the Confirmatory Grant, the Grantor granted to the Initial Administrative Agent on behalf of the Secured Parties, among other collateral, a continuing security interest in all of (1) the Grantor's right, title and interest in, to and under the trademarks and trademark applications, including the United States Trademarks listed on the attached Schedule A (the "Trademarks"), then owned or from time to time after the date thereof owned or acquired by the Grantor; (2) all proceeds thereof; (3) the goodwill associated therewith; and (4) all causes of action arising prior to or after the date thereof for infringement of such Trademarks or unfair competition regarding the same (all of the foregoing, the "Trademark Collateral");

WHEREAS, the Confirmatory Grant was recorded in the United States Trademark & Trademark Office on August 19, 2011 at reel/frame 004608/0396;

WHEREAS, on May 7, 2013, the Initial Administrative Agent executed a Notice of Substitution of Administrative Agent in Trademarks, acknowledged by the Administrative Agent and the Grantor, pursuant to which all of the Initial Administrative Agent's right, title and interest to the Trademarks and the other Trademark Collateral was transferred and conveyed to the Administrative Agent; and

WHEREAS, the Administrative Agent wishes to release its security interest in the foregoing.


NOW THEREFORE, the Administrative Agent hereby releases any security interest it may have in (1) the Trademarks and Trademark applications, including the Trademarks, now owned or from time to time after the date hereof owned or acquired by the Grantor; (2) all proceeds thereof; (3) the goodwill associated therewith; and (4) all causes of action arising for infringement of thereof or unfair competition regarding the same, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
