RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF
COLLATERAL

Reference is hereby made to that certain Pledge and Security Agreement, dated as of March 22, 2011 (the "**Agreement**"), executed by Altura Intermediate Corporation, a Delaware corporation ("**Altura Intermediate Holdings**"), whose address is 1335 S. Acacia Avenue, Fullerton, CA 92831, Altura Communication Solutions, LLC, a Delaware limited liability company (the "**Company**"), whose address is 1335 S. Acacia Avenue, Fullerton, CA 92831, and Altura CS, Inc., a Delaware corporation (together with Altura Intermediate Holdings and the Company, collectively, "**Grantor**"), in favor of Texas Capital Bank, National Association, a national banking association, ("**Secured Party**") whose address is 98 San Jacinto Blvd., Suite 200, Austin, TX 78701, which was recorded in the United States Patent and Trademark Office on March 22, 2011 at Reel 004503, Frame 0052, pursuant to which the Grantor assigned and granted to the Secured Party a security interest in and to all of the Grantor's right, title and interest in and to the Intellectual Property (as defined in the Agreement), including, but not limited to, the trademarks and other intellectual property described in **Schedule 1** attached hereto (the Intellectual Property, including such trademarks and other intellectual property described in **Schedule 1**, collectively, the "**IP Collateral**");

WHEREAS, the Obligations (as defined in the Agreement) have been satisfied and Secured Party wishes to terminate the Agreement, release said security interest in and to the IP Collateral, and retransfer and reassign to the Grantor, without representation or warranty, all of Secured Party's right, title and interest in and to the IP Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby terminates the Agreement, releases said security interest in and to the IP Collateral, and retransfers and reassigns to the Grantor, without representation or warranty, all of Secured Party's right, title and interest in and to the IP Collateral.

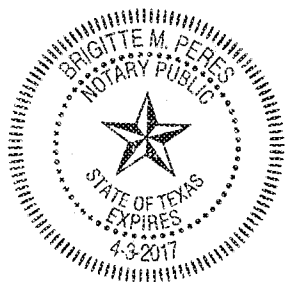
