# AFFIDAVIT CORRECTING CHAIN OF TITLE FOR HEALTH MARKET SCIENCE, INC. REGISTRATIONS

- I, Camille M. Miller, Esq., am of legal age, am a citizen of the United States and reside in Pennsylvania.
- 2. I am an attorney with the law firm Cozen O'Connor in its Philadelphia, PA office.
- 3. I am an outside counsel for Health Market Science, Inc., a Delaware corporation, hereafter referred to as "HMSI".
- 4. I have personal knowledge of the HMSI trademark portfolio and of steps taken to try to correct certain harmless errors in particular registrations and a pending application of HMSI identified in Exhibit A to this Affidavit.
- 5. Back in the year 2000, Health Market Science, Inc., a Pennsylvania corporation, merged with HMSI and HMSI then became the surviving corporation, effective on or around November 21, 2000. It is my understanding that once this merger occurred, Health Market Science, Inc., a Pennsylvania corporation, ceased to exist.
- 6. Due to an inadvertent error, the trademark applications for the marks shown in Exhibit A, excluding U.S. Trademark Application No. 77/185,136, identified Health Market Science (PA Corp.) as the Applicant for these marks, even though no such entity existed. U.S. Trademark Application No. 77/185,136 inadvertently identified Health Market Science (Del. Corp.) as the Applicant for these marks, even though the correct name of the entity was Health Market Science, Inc.
- 7. In an attempt to fix this inaccuracy, I filed, in August 2014, a "change of name" recordation for these registrations and application, identifying HMSI as the rightful owner of these marks.

- 8. I recently discovered that filing this "change of name" documentation may have been insufficient to record HMSI as the proper owner of the marks in Exhibit A, given the non-existent status of Health Market Science (PA Corp.) and, with respect to the '136 Application, Health Market Science (Del. Corp.).
- 9. In an abundance of caution, steps are now in progress to prepare and file Requests for Amendment Under Section 7(h) of the Trademark Act for each of the registrations shown in Exhibit A, and with a plan to correct the allowed, pending application shown in Exhibit A at the time a Statement of Use is filed. These filings will then reflect the correct ownership information and, with the recordation of this Affidavit, the chain of title for these registrations and application.
- 12 I hereby swear that the statements made in this Affidavit are from my personal knowledge and my knowledge of the documents referenced in this Affidavit, and are true or are believed to be true.


