## RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (“Release”), dated October 9, 2014, is made by Deutsche Bank Trust Company Americas, as Administrative Agent, with principal offices at 60 Wall Street, New York, New York 10005 (the “Administrative Agent”), in favor of CyrusOne LLC, a Delaware limited liability company, with principal offices at 1649 West Frankford Road, Carrollton, Texas 75007 (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Guarantee and Collateral Agreement (as defined below).

**WHEREAS**, the Grantor, CyrusOne Inc., CyrusOne LP, the other grantors from time to time party thereto and the Administrative Agent entered into that certain Guarantee and Collateral Agreement, dated November 20, 2012 (as amended, modified, restated and/or supplemented from time to time, the “Guarantee and Collateral Agreement”), to secure the satisfactory performance and payment of all the Secured Obligations of the Grantor;

**WHEREAS**, the Grantor, pursuant to the Grant of Security Interest in United States Trademarks, dated November 19, 2012 (“Grant of Security Interest”), granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the following (collectively, the “Trademark Collateral”):

- (i) all of the Grantor’s right, title and interest in, to and under to the United States trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto, and
- (ii) the goodwill of the businesses associated with or symbolized by the Marks;

**WHEREAS**, the Grant of Security Interest was recorded in the United States Patent and Trademark Office on November 20, 2012, at Reel 4904 / Frame 0704; and

**WHEREAS**, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. Release of Lien. The Administrative Agent hereby terminates the Grant of Security Interest and hereby terminates, cancels and releases any and all liens and security interests that it has in, to and under the Trademark Collateral.
2. Authorization to Record. The Administrative Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.
